1. Recognition of Visitors, Announcements and Updates from Trustees

(a) **Recognition of Visitors**

The Chairperson welcomed the gallery to the meeting.

(b) Trustee Sargent – Orange Shirt Day, which began in Williams Lake BC in 2013, honours the Indigenous children who were sent away to residential schools in Canada. It has become a national movement to recognize the survivors of residential schools, honour them and show a collective commitment to ensure that every child matters. Acknowledged every year on September 30th, Orange Shirt day opens the door to conversations on all aspects of residential schools and is an opportunity to create meaningful discussion about the effects of residential schools and the legacy they have left behind.

The Richmond Board of Education is committed to reconciliation and invites all members of our school communities to participate in Orange Shirt Day on September 30th.

Trustee Larson – Held annually on the 5th of October since 1994, World Teachers' Day commemorates the anniversary of the adoption of the <u>1966 ILO/UNESCO</u> <u>Recommendation concerning the Status of Teachers</u>.

In 2020, World Teachers' Day will celebrate teachers with the theme "**Teachers:** Leading in crisis, reimagining the future". The day provides the occasion to celebrate the teaching profession worldwide, take stock of achievements, and draw attention to the voices of teachers, who are at the heart of efforts to attain the global education target of leaving no one behind. The COVID-19 pandemic has significantly added to the challenges faced by already over-extended education systems throughout the world. It is no exaggeration to say that the world is at a crossroads and, now more than ever, we must work with teachers to protect the right to education and guide it into the unfolding landscape brought about by the pandemic. This year, in view of the current situation, the celebrations will take place online.

Trustee Tablotney – The Richmond Board of Education would like to extend its gratitude to Kuo Hua Trading Company for the generous donation of 10,000 face masks to benefit students in the District. The District would also like to thank the Taipei Economic and Cultural Office for its support in facilitating the donation.

The Chairperson noted that any questions submitted would be answered during the second question opportunity on the Agenda.

4. Executive

The Superintendent of Schools provided an update on the September Start-Up. Despite the many challenges, there were also many positive aspects including: the great majority of the District's students are back in school with their teachers and peers; about 95% of secondary students and 65% of elementary students are attending face to face; 3,800 elementary students and approximately 450 grade 8-9 students began the remote transitional programs. Start-Up has meant uncertainty and anxiety for many parents, but teachers, principals and vice principals have stepped up in order to meet the needs of students in a highly unusual set of circumstances.

The Superintendent thanked staff and Richmond parents for their patience and understanding as the District worked through the planning over the past month.

At the June 10, 2020 Board meeting, the Board approved a recommendation to form a Diversity and Anti-Racism Working Group during the 2020-2021 school year, comprised of trustee and stakeholder representatives. The Superintendent noted that September has been focused on school start-up but the work with this group will begin by mid-October, led by Assistant Superintendent Brautigam.

At the September 1st Trustee Workshop on the Strategic Plan, staff were given direction to continue with the stakeholder consultation process. At the upcoming Presidents Council meeting, the draft plan will be reviewed and the hope is that by the December Board meeting, the plan will be ready for approval.

The Superintendent concluded his report and introduced Deputy Superintendent Ryan to provide an update on the Equity in Action and Mental Health Initiatives. The Deputy Superintendent reported on the provincially mandated *Aboriginal Equity in Action Project* for the District in the coming year. The working group will include Trustees, the Musqueam Nation and partner groups to be shepherded by Director of Instruction, Richard Steward and District Administrator, Marie Ratcliffe who are responsible for Indigenous Learning. The Equity in Action Project will culminate in a final report to guide future direction.

The Deputy Superintendent then introduced the Director of Instruction, Learning Services to report on Mental Health Initiatives. The Director updated Trustees on two initiatives including the opening of *The Foundry*, located at 8100 Granville Avenue. The Foundry's goal is to provide walk-in integrated health supports, including counselling, for youth aged 12 – 24. The other mental health initiative is *The Integrated Child and Youth Team* who will work closely with schools and team-based primary care and specialized service providers to offer "wraparound" care to children, youth, and families.

The Assistant Secretary-Treasurer provided an overview from the Memorandum included with the Agenda. Price Waterhouse Coopers (PWC), the District's auditors, completed their audit of the 2019/2020 financial statements.

They expressed an unqualified audit opinion that the financial statements are complete, accurate in all material respects and prepared in accordance with accounting requirements under PSAB and *Section* 23.1 of the *Budget Transparency and Accountability Act of BC*.

Some key highlights included: total student enrolment increase of 179.3 fte students; the total operating revenues at \$212.5 million; International student program gross revenues at \$18.4 million; \$34.9 million funding for the Classroom Enhancement Fund to cover 398.14 fte in additional teachers and classroom supports.

The Assistant Secretary-Treasurer thanked Pramod Chauhan, Manager, Financial Services and the entire Finance Team for the invaluable contribution in the preparation of the year-end financial statements.

The Committee Chair noted that the Auditors were very impressed with the expertise and excellent work in preparation for the audit. Trustees thanked the Assistant Secretary-Treasurer and team for all the hard work and excellent preparation and outcome as expressed by PWC.

This report is provided to the Board for information purposes. No further action on behalf of the Board is required at this time.

Introduction:

The purpose of this report is to provide an update regarding K-12 school-aged full-time equivalent (FTE) totals for September 2020.

Enrolment Data:

All figures in the charts below represent enrolment FTE and <u>not</u> student headcount figures. As indicated, the district experienced a net decrease of enrolment FTE in a number of areas when compared to the 2020/21 enrolment projections.

Conclusion:

Actual September 30, 1701 final enrolment FTE will be reflected in the Ministry of Education operating grant recalculation which is expected to be announced some time in December. Assuming no funding formula changes or adjustments, the enrolment FTE in the areas included in the charts above amounts to a **\$1,545,300** decrease to the operating grant funding.

Decreased operating grant funding, and re-casted revenues and expenditures will be reflected in the 2020-21 Amended Annual Budget.

INTRODUCTION

Richmond International Education (RIE) is a program of choice that has been providing significant and measurable benefits to the District for the past 22 years. This report is intended to comment on the recent successes and challenges of the program and to share our plans for the future in order to facilitate continued success.

The program consists of short-term and long-term study options; an after-school program (Connections); group programs; as well as professional learning programs (administrators and teachers) that are delivered on-shore (Richmond) and off-shore, primarily in China.

Since our last report submitted to the Board on September 11, 2019, our program has experienced unprecedented pressures and challenges. The first half of the 2019-2020 fiscal year was characterized by continued program diversification, enriched participant engagement, enhanced communication and student support, and heightened sectoral collaboration. Unsurprisingly, the second half of the fiscal year was dominated by the emergence and evolution of the novel coronavirus, COVID-19.

Approximately 2200 students and educators from 23 countries participated in one or more of our programs. However, China remains our greatest current and future source of program participants.

While our long-term study program remains our most popular program and main focus, we continue to work on augmenting program options and developing new opportunities beyond our long-term study program to supplement revenue, add diversity, and support the sustainability of the program overall. We continue to enhance our professional learning services, short-term and group program offerings, and provide additional supports for students, schools, and families.

PROGRAM DEVELOPMENT

Our program will continue to reflect the internal and external opportunities and pressures within and beyond the district. We continue to manage our evolution in a measured and

thoughtful fashion in order to maintain program quality and accessibility for our students and schools. COVID-19 had a singular impact on our program. The global pandemic will likely continue to have an unparalleled influence on our program for the next 2-3 years.

DIVERSIFICATION

The program experienced growth in interest and participation levels from students, parents, schools, education bureaus, and study abroad organizations in Mexico, Thailand, Vietnam, Italy, Spain, and Germany. Our short-term and professional learning programs continued to expand in depth and breadth to meet participant interests and educational goals. We supported school-based events and activities that encouraged interculturalism, and mobility opportunities for students and educators through our new Interculturalism Fund. We also facilitated exchange and mobility awards through the provincial government's Student Exchange and Mobility Award program. Regrettably but understandably, all overseas trips had to be cancelled due to COVID-19. Our homestay program continues to grow and allow us to accommodate the diversification of student requests, needs, and interests.

ENGAGEMENT

Our engagement objectives included launching the Richmond International Student Forum (RISF), creating the Interculturalism Fund, offering fieldtrips to Banff, ski trips to Whistler, revising International Student handbooks, increased website and Social Media presence, and more in-person and virtual points-of-contact with schools, students, and their responsible adults. Engagement levels increased as we reckoned with the impact of COVID-19, which included the rollout of remote learning, considerations for student and responsible adult safety, health, and well-being, implications for medical insurance coverage, and travel restrictions.

SUPPORT

RIE provides international students with comprehensive 24-7 wrap-around care. The integration of our online ELL assessment tool into our True North database, as well as the successful piloting of the grade 4-7 assessment tool, has afforded us the ability to better support our students and schools, and minimize our environmental footprint. We integrated the new International Student Health Fee to ensure our students maintained full medical insurance coverage and we were in compliance with the new regulation. In addition, various traditional and new modes of communication were employed to support students and responsible adults through the vagaries of COVID-19.

COLLABORATION

RIE took a more active role in provincial (IPSEA) and national (CAPS-I) sectoral associations by contributing to provincial and federal government initiatives and dialogues, and initiating regular Metro Vancouver peer program discussions on best practices in international education.

CONCLUSION

The Richmond International Education (RIE) team is dedicated and works diligently to maintain a vibrant, diverse, and comprehensive program. This program involves an increasingly wide

variety of participants, ranging from students, parents, government, professional staff and our broader community, which in turn serves to foster greater international understanding and relationships.

RIE is also important for the support it provides for the various initiatives of the Board and Senior Administration. Regular communication and dialogue with the Board, our school communities, and the public is not only valued, but necessary in order to meet the needs of our district and the needs of our international students and their families.

It is anticipated that due to the global pandemic our program will need to adjust to a "new normal" while continuing to be able to make a significant contribution to the District which enhances the schooling experience for all Richmond students. The guidance and support of the Board is essential as the program continues to evolve.

The following report to the Board is for information only. No further action on the part of the Board is required at this time.

Background

Foundry Richmond is part of a network of innovative Youth Services Centres throughout British Columbia that are designed to address mental health, substance use, and primary care needs for young people between the ages of 12 to 24. Foundry Richmond offers a single point of access to health care providers, welcoming experts and peers who assist young people and their families with how to navigate health/social services and intervention/support programs.

For young people, delays in access to health services and supports can lead to a lifetime of disability, lost productivity, and high health care utilization. Seventy-five percent of all lifetime cases of mental illness begin before the age of 24, while 80% of substance use problems start before age 20. The McCreary BC Adolescent Health Survey (2018) revealed that 6,400 youth in Richmond struggled to access primary or mental health care when they needed it. The increase in Richmond RCMP mental health and substance use calls for youth, and the rate of admissions to Richmond Hospital indicates that many young people are not accessing necessary services until they are in a crisis.

The Foundry Model of Support

Foundry's mandate is to provide young people with safe, non-judgmental care and resources in a timely way - before health challenges become increasingly problematic. Foundry brings health and social services together under one roof to make it easier for young people to access the care, connection, and supports they require. Care and support are provided in a stepped care model which matches the level of service to the individual need. If a young person demonstrates the need for increased levels of support, such supports are made available. Conversely, if a young person's situation improves, the intensity and level of support will be reduced appropriately. This approach results in the efficient and effective allocation of resources. Foundry Richmond Location

Foundry Richmond opened in July 2020 in a temporary location provided by Vancouver Coastal Health at 8100 Granville Avenue, and has been providing both in-person and virtual supports to youth. It is hoped that a permanent location near city centre will be operational in the future.

Richmond School District Involvement

Vancouver Coastal Health is the lead agency on this initiative and has partnered with the Richmond School District, the Ministry of Child and Family Development, and Richmond Addiction Services to form an advisory group. The district is represented by Richard Steward, Director of Instruction on the advisory group while other district staff, students and alumni participate in working groups focussing on topics such as youth engagement and partner agency cooperation.

The Foundry community partnership comes at no cost to the school district.

Re: Foundry Richmond Update

This letter is in response to a request made at the Council/School Board Liaison Committee meeting on October 7, 2020 that follow-up information about Foundry Richmond be provided to the Richmond School District.

Foundry Richmond is now offering services to Richmond youth and their families at its interim location at 8100 Granville Avenue. Foundry Richmond is one of 11 Foundry Centres that have opened across the province. An additional eight Centres are opening soon. Foundry provides young people ages 12 to 24 years access to mental health care, substance use services, primary care, social services, and youth and family peer supports. Foundry Richmond works collaboratively with community agencies to help bridge gaps and remove barriers for youth to access health services before challenges become problematic.

On July 15, 2020, Foundry Richmond soft-launched services at their interim location. Services include a sexual health clinic, drop-in counselling, peer support, and access to mental health and substance use supports. Foundry Richmond's operating hours are Monday to Friday from 9:00 a.m. to 4:30 p.m. with services offered both in-person and virtually.

In addition to the opening of Foundry Richmond, Foundry BC recently launched a new province-wide virtual service which provides counselling, peer support check-ins and group offerings, accessible by voice, video and chat for young people and their families. Hours are Monday to Friday from 1:15 to 9:00 p.m. To book an appointment for this virtual service, call 1-833-308-6379 or visit www.foundrybc.ca.

As of October 1, 2020 Vancouver Coast Health (VCH) took over responsibility from Richmond Addiction Services Society (RASS) as the lead agency for Foundry Richmond. As the lead agency, VCH continues to search for a larger, permanent site to deliver services to the community. The City also maintains involvement as a member of the Richmond Foundry Leadership Advisory Council and participates in planning as a partner and key stakeholder.
