STRATEGIC PLAN REFERENCES

Strategic Priority 3: Optimized Facilities & Technology

✓ Goal 2: The district's facilities are well-maintained, equitable, safe, and conducive to learning.

DISCUSSION

Major Items of note:

1. Long Range Facilities Plan (LRFP):

The Planning Team updating the LRFP Action Plan, track planning actions, facilities decisions of the Board of Education and potential or recommended changes for the next revision of the LRFP in 2023.

2. Childcare BC New Spaces Fund (NSF):

The District has already received funding approval of NSF funding approval to create new childcare facilities at Manoah Steves Elementary and Maple Lane Elementary. The District has selected Fort Modular to construct two modular childcare buildings for installation by December.

In preparation for the next intake of NSF applications for new stand-alone childcare facilities anticipated in the Spring/Summer of 2022, the Planning Team is undertaking a comprehensive review of suitable candidate sites for future childcare facility proposals.

3. Just B4 Program:

Walter Lee Elementary has been approved to accommodate Just B4 beginning in September 2022. The Planning Team is continuing to support Learning Services in identifying future opportunities for expansion of this program to other elementary schools where appropriate.

4. Integrated Child & Youth Teams (ICY):

R.M. Grauer Elementary and Kathleen McNeely Elementary have been selected by the District to accommodate ICY Teams beginning in September 2022. The Planning Team worked closely with Learning Services and Vancouver Coastal Health on scope of work and is proceeding with renovations at the two sites to create the office space for ICY Teams. The Planning Team will also review the availability of two future locations to help determine if the District can meet the long term objective of locating ICY Teams within schools in four zones across the District.

5. Aspen Program:

In collaboration with Facilities Services, and in consultation with Learning Services and A.R. MacNeill Secondary, the Planning Team is finalizing a detailed report to Senior Team on potential relocation options for the Life Skills Program to facilitate the accommodation of the Aspen Program entirely on the ground floor.

6. Five-Year Capital Plan/Eligible School Site Proposal (ESSP):

These documents have been drafted and are due to the Ministry of Education by 30 June 2022. They will be presented for Board approval at the 29 June 2022 meeting.

7. <u>Seismic Mitigation Program</u> (SMP):

Development of Project Definition Reports (business cases) for the recently Ministry-supported seismic upgrades at Alfred B. Dixon Elementary and Howard DeBeck Elementary underway, targeting completion by end of June 2022.

8. City Centre Growth Planning:

The Planning Team is continuing to research and engage with the City of Richmond and development community on the timing and financial viability of a suitable new elementary school in the City Centre at Dover Park, Lansdowne Village, or elsewhere in the City Centre.

9. Coordination of Land Management with City of Richmond - Park Sites with School Sites:

Facilities Planning staff will be meeting with City of Richmond Parks and Open Space planners to discuss possible improvements to shared use and management of parks and adjoining school playgrounds for use by school and community.

- A. Major Capital Projects (capital projects \$1 Million or more funded by the Province)
 - 1. F.A. Tomsett Elementary Seismic Upgrade & Addition (\$11.4 Million)
 - Seismic upgrading and expansion work on school and construction of new Tomsett Childcare
 Facility substantially complete on main school and new Tomsett Childcare Facility (to be
 fully operational in August 2022); addressing deficiencies, outstanding exterior work and
 demobilization; both on budget.
 - 2. <u>James McKinney Elementary Seismic Upgrade</u> (\$12.6 Million)
 - Substantial completion by end of June 2022; on budget.
 - 3. James Whiteside Elementary Enhanced Seismic Upgrade (\$17.3 Million)
 - Construction underway; targeting substantial completion by end of June 2023; on budget.
 - 4. William Bridge Elementary Seismic Upgrade (\$16.1 Million)
 - Construction underway; targeting substantial completion by end of August 2023; on budget.
 - 5. Archibald Blair Elementary Building Envelope Upgrade (approx. \$2.2 Million)
 - Design underway under the project management of BC Housing with oversight and district coordination by SD38; expect construction to start in Fall 2022.

- 6. Howard DeBeck Elementary and Alfred B. Dixon Elementary Seismic Upgrades (approx. \$33 Million)
 - Consultants retained and work on Project Definition Reports (business cases) well
 underway; targeting completion for submission to the Ministry for project approvals by
 Summer 2022.
- 7. Manoah Steves Elementary and Maple Lane Elementary Childcare Facilities (\$1.5 Million each)
 - Request for proposals to design/build/install the modular childcare facilities closed 13 May 2022; evaluation of both proposals received, followed by negotiations with top proponent on contract underway.
- B. **Major Local Capital Projects** (capital projects greater than \$1 Million funded by Board of Education)
 - 1. Mitchell Education Centre (\$2.5 Million)
 - Work well underway with completion/occupancy by 31 August 2022; on budget.
 - 2. Rideau Park Resource Centre (\$1 Million)
 - Preliminary design of the project continues; expect to start construction in September 2022 with completion by May 2023.
 - 3. <u>Classroom Ventilation Program</u> (\$12 Million max.)
 - Request for proposals completed for the supply and delivery of 187 unit ventilators over a 14 month period; contracts awarded to the two successful proponents with initial deliveries set for Summer 2022.
 - Executive Director working with SD38 HVAC Team and independent consultant to complete the fine-tuning of concept plans for the design/build by both in-house and contracted forces
- C. Minor Capital Projects (less than \$1 Million funded by the Province)
 - 1. Howard DeBeck Elementary Building Envelope Upgrade (approx. \$400,000)
 - Design underway under the project management of BC Housing with oversight and district coordination by SD38; expect construction to be undertaken as part of seismic upgrade project.
 - 2. Mechanical System Upgrades
 - Shop dust extraction system replacement at Matthew McNair Secondary in design (2022/23 SEP \$472,000).
 - HVAC digital controls replacements at Hugh McRoberts Secondary and Lord Byng Elementary in design (2022/23 CNCP \$371,500).
 - Lab ventilation system upgrades at four secondary schools (A.R. MacNeill, H.J. Cambie, Matthew McNair, Steveston-London) in design (2022/23 SEP \$252,730).

3. <u>Electrical System/Energy Upgrades</u>

- LED lighting upgrade at Steveston-London Secondary 95% complete; targeting completion by end of June 2022 (2021/22 CNCP \$550,000).
- LED lighting upgrade at R.A. McMath Secondary approved by the Ministry in 2022/2023 Capital Plan, in design (2022/23 SEP \$547,287).

7. New Business

a. Provincial Child Care Updates

The Province of BC began funding \$10 a Day ChildCareBC sites in 2018 with funding from the Canada-British Columbia Early Learning and Child Care Agreement (ELCC). In 2022, the Province has expanded the program with a goal of reducing child care fees to families in 12,500 child care spaces by the end of 2022. An announcement of the additional selected sites was released by the Province on March 24, 2022. Three City-owned child care facilities, West Cambie and Cook Road Children's Centres, operated by the Society of Richmond Children's Centres (SRCC) and Seasong Child Care Centre, operated by the YMCA of Greater Vancouver, will transition to \$10 a Day ChildCareBC sites beginning April 1, 2022.

Also effective April 1, 2022, responsibility for child care in BC transitioned from the Ministry of Children and Family Development to the Ministry of Education and Child Care. All existing funding programs and initiatives have now transitioned to this new Ministry.

b. Child Care Referral from City of Richmond Planning Committee

At the Planning Committee meeting held on March 22, 2022 a referral was made that staff investigate developing a city-wide child care contribution policy for all Richmond developments, and report back. This work will begin soon and additional information will be shared with the CCDAC once it is complete.

i. Advocacy Sub-committee

ii. Child Care Month Sub-committee

- i. 2022 Child Care Symposium –Registration is underway through the Richmond Child Care Resource and Referral Program and will continue until the event which takes place on May 7, 2022.
- ii. 2022 Children's Art Exhibition Eighteen child care programs have been accepted to the exhibition for this year. The exhibition will be on display on the Community Art Wall of the Brighouse Branch of the Richmond Public library from May 2 to 22, 2022.

b. City Reports

i. Council Liaison

The City of Richmond is currently seeking public feedback on the Draft Seniors Strategy. Earth day will take place on April 16 and there are several events planned that may be of interest to child care providers. The Cherry Blossom Festival is currently underway at Garry Point. The Garden City Lands will have 200 new garden plots. These were opened earlier this week and this is a great place to take children to learn about gardening.

ii. Staff Liaison

School District Reports

i. School Board Liaison

Richmond School District has received Childcare BC New Spaces funding for two new projects in Richmond schools. Richmond School District has received at total of \$3

million to include child care at Maple Lane and Minoah Steeves Elementary Schools. These will be purpose-built, modular structures to deliver licensed child care and will be leased to community child care providers upon completion. Staff are also preparing applications for the next new intake of funding in order to develop additional spaces.

The JustB4 program, a licensed preschool program for four year old children, which operated as a companion with a Strongstart Centre, has just been licensed and is commencing operations. This program will be delivered directly by school district staff. The Richmond School District is working to utilize existing school facilities as much as possible to support the delivery of licensed child care in Richmond.

ii. Community Updates

i. Richmond Children First

Richmond Children First met on March 29 and approved the committee's work plan for this year. A presentation from the Human Early Learning Partnership (HELP) at UBC is being planned for this fall.

ii. Child Care Resource and Referral (CCRR) Update

The Child Care Resource and Referral Program (CCRR) is involved in consultation regarding the transition of child care to the Ministry of Education and Child Care. Staff have participated in many discussion groups and conversations regarding this process and the potential impacts to the sector. It has been clear from these discussions that everyone involved wants the best for children and this is a priority.

CCRR's annual membership renewals continue. General membership is free and additional access to services and supports is available for a minimal cost. CCRR is also transitioning back to in-person workshops. The first in-person sessions are taking place on April 19 and April 27. The topic is the Impacts of Covid 19 on Children's Mental Health. The Introduction to Family Child Care Training in Mandarin is also beginning this week and will continue until the end of May.

Recent additional wage enhancements to ECE's are fantastic but there is still a shortage of ECE's and this is currently a significant issue in Richmond and in the sector as a whole. Bursaries and educational resources are available on the provincial government website. CCRR has job posting site as well for programs who are looking for staff or staff who are looking for employment.

2017–2022 Richmond Child Care Needs Assessment and Strategy

- The 2017–2022 Richmond Child Care Needs Assessment and Strategy was adopted by City Council on July 24, 2017.
- It is the fourth child care needs assessment undertaken by the City since 1995 and provides insight into the status of child care in Richmond.
- This five-year plan for the City outlines steps to support the development of a healthy child care system in the community and guides the City's actions.
- It recommends that the City and other stakeholders work together to address the need for quality, affordable and accessible child care spaces in Richmond.



2017–2022 Richmond Child Care Needs Assessment and Strategy

Actions in this document are organized under 7 Strategic Directions

- Strategic Direction #1: Policy and Planning
- Strategic Direction #2: Creating and Supporting Spaces
- Strategic Direction #3: Advocacy
- Strategic Direction #4: Accessibility and Inclusion

- Strategic Direction #6: Research, Promotion and Marketing
- Strategic Direction #7: Monitoring and Renewal



Federal Government Highlights

- July 8, 2021: New Early Learning and Child Care Agreement between Governments of Canada and BC
 - Investment of \$3.2 billion (Federal) and \$2.5 billion (Provincial) over the next five years
- November 23, 2021: The House of Commons Speech from the Throne outlined child care as an important service to grow the economy.
- **December 16, 2021:** The Minister of Families, Children and Social Development Mandate Letter outlines the importance of a Canada-wide Early Learning and Child Care system.



Provincial Government Highlights

- October 27, 2021: The Early Learning and Child Care (ELCC) Act and the Early Childhood Educators (ECE) Act become law
 - The ELCC Act combines the Child Care BC Act and the Child Care Subsidy Act
 - The ECE Act incorporates ECE and post-secondary ECE provisions outlined in the Community Care and Assisted Living Act and Child Care Licensing Regulation



Provincial Government Highlights

- November 16, 2021: The Childcare BC New Spaces Fund closed a new round of funding for projects up to \$3 million (public sector/government) and \$1.5 million (not-for-profits)
 - A total of 3,624 new child care spaces were funded in 2020 403 of these spaces were located in Richmond
 - 3 City-owned child care facilities were supported through this funding in 2020: Sprouts ECD Hub, Seedlings ECD Hub and Hummingbird Child Care Centre



Richmond Child Care Supply 2020 and 2021








Richmond Child Care Supply 2016 to 2021
